

Impac Mortgage Holdings, Inc. Announces First Quarter Earnings Conference Call, Upcoming Filing of Its 2004 Form 10-K/A and Form 10-Q for the First Quarter 2005 and Posting of Its Unaudited Monthly Fact Sheet for the Month of March 2005

The Mortgage Operations acquires, originates, sells and securitizes primarily Alt-A mortgage loans and the Warehouse Lending Operations provides short-term financing to mortgage loan originators. The Company is organized as a REIT for tax purposes, which generally allows it to pass through earnings to stockholders without federal income tax at the corporate level.
