ANNOUNCES CONFIRMATION OF JOINT PREPACKED CHAPTER 11 PLAN OF REORGANIZATION**

[OTC Pink Limited: IMPM] (the “Company”) announces that on May 29, 2026, the U.S. Bankruptcy Court for the District of Delaware (the “Court”) confirmed the Company’s Joint Prepacked Chapter 11 Plan of Reorganization (“Plan”) in the matter In re Impac Mortgage Holdings Inc., et al., (Case No. 26-10593 (CTG)). The Plan will become effective once certain conditions precedent are met as required under the Plan.
