



IMPAC MORTGAGE HOLDINGS, INC. DISCLOSES LITIGATION SETTLEMENT

Newport Beach, CA, May 8, 2025 – Impac Mortgage Holdings, Inc. [OTC Pink Limited: IMPM] (the “Company”) and its subsidiary, Impac Funding Corporation, entered into a Confidential Settlement and Release Agreement on May 1, 2025 (“Settlement Agreement”), in connection with the matter *UBS Americas Inc. et al. v Impac Funding Corporation et al.*, pending in the Supreme Court of the State of New York, County of New York (“Court”). The Settlement Agreement resolved any and all claims between the parties in connection with the matter. On May 6, 2025, the parties filed a Stipulation of Voluntary Discontinuance with Prejudice with the Court.
