



IMPAC MORTGAGE HOLDINGS, INC. DISCLOSES FORBEARANCE AGREEMENT EXTENSION

Irvine, CA, July 29, 2025 – Impac Mortgage Holdings, Inc. [OTC Pink Limited: IMPM] (the “Company”) is a party to a Forbearance Agreement that it entered into in connection with its Junior Subordinated Indenture Notes (as defined below), which was amended by the first amendment through fifth amendment to such Forbearance Agreement. On July 28, 2025, the Company entered into sixth amendment to such Forbearance Agreement whereby the expiration date of such Forbearance Agreement was extended to December 1, 2025.

“Junior Subordinated Indenture Notes” means those certain notes issued under the Junior Subordinated Indentures, both dated as of May 8, 2009, between the Company and The Bank of New York Mellon Trust Company, National Association, as trustee, in the total original principal amount of Sixty-Two Million Dollars (\$62,000,000).
