



**IMPAC MORTGAGE HOLDINGS, INC.
DISCLOSES LOAN AGREEMENT BREACH/WAIVER
AND FORBEARANCE AGREEMENT EXTENSION**

Newport Beach, CA, May 1, 2025 – Impac Mortgage Holdings, Inc. [OTC Pink Limited: IMPM] (the “Company”) recently requested, and received on April 25, 2025, a waiver of breaches of certain monthly and quarterly financial covenants under its revolving credit facility.

In addition, as previously disclosed, the Company is a party to a Forbearance Agreement that it entered into in connection with its Junior Subordinated Indenture Notes (as defined below), which was amended by the first amendment through fourth amendment to such Forbearance Agreement. On April 30, 2025, the Company entered into fifth amendment to such Forbearance Agreement whereby the expiration date of such Forbearance Agreement was extended to August 9, 2025.

“Junior Subordinated Indenture Notes” means those certain notes issued under the Junior Subordinated Indentures, both dated as of May 8, 2009, between the Company and The Bank of New York Mellon Trust Company, National Association, as trustee, in the total original principal amount of Sixty-Two Million Dollars (\$62,000,000).
