Newport Beach, CA, January 27, 2025 – Impac Mortgage Holdings, Inc. [OTC Pink Limited: IMPM] (the “Company”) recently requested, and received on January 21, 2025, a waiver of breaches of certain monthly and quarterly financial covenants under its revolving credit facility.
